The Emergence of Mental Health Counseling

Gibson and Mitchell (2003) wrote “The trauma of the Vietnam War and the postwar era for many veterans and their families created another population in need of mental health counseling. Also during the 1960 and 1970s, increased substance abuse and public awareness of the extent and seriousness of the problem at all age levels led to research, the development of training programs, and the growth of another area of specialization for counselors. Additionally, attention to preparing specialists for correctional counseling and counseling for the elderly reflected a concern for the needs of these populations as well.

The Community Mental Health Centers Amendments of 1975 (Public Law 94-63) redefined the notion of a comprehensive community mental health center from the five minimum and five optional services to a mandated set of 12 services. They include the five originally established services (Inpatient, Outpatient, Partial hospitalization (e.g., day and/or night hospitals), Emergency care (e.g., 24-hour crisis services) and Consultation (e.g., indirect service and community education (i.e., prevention) plus these seven:

1. Special services for children
2. Special services for the elderly

3. Preinstitutional screening and alternative treatment (as pertains to the courts and other public agencies)
4. Follow-up for persons discharged from state mental hospitals
5. Transitional living for persons discharged from state mental hospitals
6. Alcoholism services (prevention, treatment, and rehabilitation)
7. Drug abuse services"

President Jernigan's goals included developing organizational policies for AzPGA, organizing the AzPGA fall convention, organizing a leadership workshop, organizing regional/divisional workshops, continuing support of counselor workshops in the state, expanding and developing counselor credibility and continuing work with the Western Region Branch Assembly of APGA. Past President Joan Schipper reported that the first organizational meeting of the new state certification commission was held in September with Dr. Tom Reno, ex officio member from the ADE, acting as chair. Jim Fredrick of Flagstaff, Les Snyder of Arizona State University and Rand Eubank of the Department of Education met with Dr. Reno to inform him of the many discrepancies which exist between what the task force had recommended regarding counselor certification and what appeared in the final written report. Arizona school counselors were urged to let Berkley Lunt of the Department of Education Certification Unit know how much we thought we must have practicum as one of the requirements for counselor endorsement.

Randy Eubank wrote a letter for Susan Jernigan supporting the need for a statewide computer-based career information system.

The 1979 APGA Senate passed an anti-discrimination resolution which also had to be passed by all national divisions and state branches.
